



YOGAKIDS APPRENTICE (YKA) AGREEMENT

By authorizing these terms, you enter into an agreement with YogaKids International Corporation ("YKI") as a YogaKids Apprentice ("YKA").

1. Definitions

YKA is an active enrollee in the YogaKids Advanced Certification Training Program
Certified YogaKids Teacher (CYKT) is the title given to a person who is a graduate of Levels I, II and III of the YogaKids Advanced Certification Program and maintains an active license from YogaKids as outlined below

License is the limited rights granted to YKAs to use the YogaKids trademark as specifically set forth below

YogaKids Advanced Certification Training Program is the program more fully described on the YKI website. <http://yogakids.com/training-and-certification/>

2. YKA Terms

The right to participate in the YKI Advanced Training Program as a Level II or Level III trainee

Online access to the YKI password-protected YogaKids University and private FB Forum

The right to participate in monthly continuing education webinars

Name, designation (YKA) and contact information listed on yogakids.com

The right to purchase YogaKids store products at a YKA discount rate

The right to use the YKA logo, set forth in Exhibit A, on a non-exclusive, non-transferable, non-assignable basis during the Term of this Agreement

3. Payment

The course fee is as set forth in the YKI online portal and payable as elected by the YKA in the online portal. Travel, food and lodging are not included.

Upon graduating from Level III of the YKI Advanced Training Program, you have the right to become a licensee and enter into the CYKT Rights Agreement, attached hereto as Exhibit C.

4. Collateral Materials, Social Media and Web Presence Guidelines

YKA is required to use YKI approved verbiage when promoting YK classes and programs. YKA acknowledges that he/she is not a business affiliate or unit of YKI. YKA is not allowed to (i) use the name YOGAKIDS or "YOGAKIDS of xyz" to describe their business; or (ii) use YogaKids in their corporate identity, URL or in social media sites.

YKA shall abide by all future guidelines promulgated by YKI and shall adhere to all quality control requirements of YKI. The YKA website and promotional materials shall be of the same or better quality than that of YKI.

5. Term

This Agreement shall commence upon signing and shall continue for so long as YKA remains in compliance with the terms and conditions of this Agreement. This Agreement shall continue until entering in the CYKT Rights Agreement, for students who become graduates or shall terminate if (i) YKA's failure to successfully pursue and complete the YogaKids Advanced Training Program, as determined by YKI in its sole discretion; or (ii) upon YKA's failure to pay the fees

outlined above; or (iii) upon breach of this Agreement by YKI Student.

6. Reservation of Rights/Limitation of License

YKA acknowledges YKI's rights to its YogaKids trademark and to its proprietary, copyrighted materials, including manuals, handouts, as well as all materials comprising subsequent editions of the YogaKids curriculum and training curriculum ("Materials"). YKA agrees not to use any of the YogaKids trademarks or Materials without the express written consent, except as is authorized by this Agreement.

7. Best Practices

To protect yourself, your students and YKI, YKA agrees to take all reasonable precautions to ensure their students are safe. YKA shall have each of their students over the age of 18 and a parent/guardian of each student under 18, sign a copy of a Release in a form similar to that attached hereto as Exhibits B, and to maintain each signed form on file until the later of (a) the time the student attains the age of 24 or (b) three years from the date the student takes their last class with YKA.

8. Indemnification

You agree to indemnify YKI and hold harmless YKI, its shareholders, directors, officers, employees and agents from any and all liability, loss, damage, costs or expenses, including attorney(s) fees, arising out of or in any manner whatsoever relating to your teaching yoga classes and/or seminars using YogaKids methods. YKA residents of the United States must maintain current business liability insurance in an amount not less than \$1,000,000 per occurrence that lists YKI as additionally insured. YKA must provide a copy with each renewal to notify YKI in the event the policy is in arrears and/or terminated. For YKA's residing outside the United States, it is recommended you follow the guidelines of your respective country regarding liability insurance.

9. Miscellaneous

This Agreement contains all oral and written agreements, representations and arrangements between the parties with respect to its subject matter, and no representations or warranties are made or implied, except as specifically set forth herein. No modification, waiver or amendment of any of the provisions of this Agreement shall be effective unless in writing and signed by all parties to this Agreement. No waiver of any breach of any terms of this Agreement shall be effective unless made in writing signed by the party against whom enforcement of the waiver is sought, and no such waiver shall be construed as a waiver of any subsequent breach of that term or any other term of the same or different nature. This Agreement may not be assigned by YKA without prior written consent of YKI. This Agreement shall be binding upon and inure to the benefit of the parties, their successors and, subject to the above limitation, their assigns, and shall not be enforceable by any other third party. This Agreement shall be interpreted and construed pursuant to the laws of the State of Michigan without regard to conflict of laws rules applied in the State of Michigan. The parties hereto hereby consent to personal jurisdiction and venue exclusively in the courts that service New Buffalo, MI with respect to any action or proceeding (including, without limitation, all pretrial proceedings and party depositions) brought with respect to this Agreement. Each party agrees to accept service of process by mail to the addresses set forth below (as such address may be amended in writing). Any judgment in any such action shall include an award of legal fees and costs to the prevailing party. Each of the



parties (a) is sophisticated in negotiating business transactions, (b) is, or has had the opportunity to be and has elected not to be, represented by counsel, (c) has reviewed each of the provisions in this Agreement carefully and (d) has negotiated or has had full opportunity to negotiate the terms of this Agreement, specifically but not limited to, the first sentence of this paragraph.

10. Refund and Cancellation Policy

No refunds will be given on purchases of **Level I Training (Foundations)**, **Level II Training (Integrations)**, **Level III Training (Transformations)** and any combination thereof.

Registration/Lodging Purchase: If you must cancel (includes no-shows), certain fees/penalties may be applied based on the location of the training and the timing of your cancellation request. Confirmations made within 30 days or less of the training date may be assessed a late sign-up fee. If lodging fees are being paid through YogaKids International, cancellation/refund policies vary depending on the location. If lodging is paid/booked through the facility, please contact the facility regarding their cancellation policy. Please note that travel and or lodging are **not included** in the cost of Foundations or Transformations. Contact us in an email with any specific cancellation requests.

Payment Plans: No payment plan cancellations allowed. All payments must be paid in full. Plan must be paid in full prior to attending a Level 3 event.

Training Cancellation Policy: YogaKids reserves the right to cancel or reschedule trainings. We will make every effort to put you in another training of your choice.

11. Advanced Training Program Guidelines

Level 1 Training is open to all. The prerequisite for Level 2 is Level 1. Trainees must sign-up for Level 2 within one year of completing Level 1. Trainees wishing to continue to Level 2 outside of the one-year mark must attend a Level 1 Training again but can do so at 50% off the regular ticket price – contact us for details.

Trainees who purchase a Level 2 Training have 1 year to complete it. Six-month extensions (available for \$125 per 6-month term) are available for purchase, but they must be purchased prior to the 1 year anniversary date. Trainees who do not complete the Level 2 Training within the 1-year anniversary of purchase and do not purchase an extension will be subject to review and will need to pay \$250 to re-enter the program for another 6-month term.

Level 2 trainees may purchase/register for a Level 3 Training at any time. Attendance at a Level 3 Training is open to only students that have completed Level 2 of the YogaKids Certification Track.

Level 2 graduates have 1-month upon completing Level 2 to either purchase a Level 3 Training or a YKA Continuing Membership. This Continuing Membership allows Level 2 graduates to retain their Level 2 benefits and keep their YogaKids Apprentice status “active.” Active Level 2 graduates are eligible to attend/purchase a Level 3 Training and complete the journey to certification at any time.

Level 3 graduates (our Certified YogaKids Teachers) have 1 month after completing all 3 levels to purchase a CYKT Membership/License. This monthly licensing/membership fee allows Level



3 graduates to retain designation as a “Licensed Certified YogaKids Teacher” and keep exclusive CYKT benefits.

Trainees who purchase Full Certification (Levels 1, 2 and 3 together) will begin their Level 2 training within 30 days of completing Level 1. Trainees who purchase Full Certification have 1 year to complete Level 2 once they begin the online Training. (Six-month extensions for completing the online trainings are available for purchase, but they must be purchased prior to the 1 year anniversary date.)

Trainees who have purchased Full Certification have 1 year after completing Level 2 to attend a Level 3 Training or to purchase a YKA Continuing Membership. This monthly membership allows Level 2 graduates to retain their Level 2 benefits and keep their YogaKids Apprentice status “active.” Active Level 2 graduates are eligible to attend a Level 3 Training and complete the journey to certification at any time.

License is the limited rights granted to CYKTs to use the YogaKids trademark as specifically set forth below.

2. CYKT Terms

A CYKT shall be granted the following rights:

- Online access to the password-protected YogaKids University which includes but not limited to marketing assets, teaching tools and Video Pose Catalog
- Access to the private teacher Facebook Forum
- Access to monthly continuing education webinars
- Receipt of YogaKids community newsletters
- Receipt of a premium listing on yogakids.com that includes name, designation (CYKT), bio, photo and contact information
- Discount rate on YogaKids store products
- Use of the CYKT logo, set forth in Exhibit A, on a non-exclusive, non-transferable, non-assignable basis during the Term of this Agreement

10. Refund Policy

No returns will be accepted on orders made through CYKT or YKA store (apprentice or licensee discounted product). No refunds are available on licensing dues.

11. Termination Policy

YKI may terminate this agreement for cause at any time effective upon written notice. CYKT may terminate this agreement at any time effective upon written notice to YKI. Agreement will automatically terminate after more than 30-days non-payment of licensee dues. Upon termination of this agreement by either party, CYKT relinquishes the rights listed in the terms of this agreement and must immediately cease any and all uses of the licensed name and trademark and copyrighted, proprietary material.

12. Reinstatement Policy

Upon request, a non-active CYKT may return as a licensee after a review process by the YogaKids leadership team. Those accepted will need to pay a reinstatement fee of \$40.
